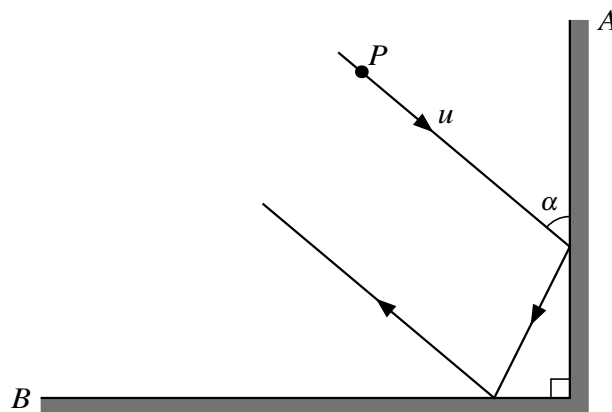

- 1 Two uniform small smooth spheres, A and B , of equal radii and masses 2 kg and 3 kg respectively, are at rest and not in contact on a smooth horizontal plane. Sphere A receives an impulse of magnitude 8 N s in the direction AB . The coefficient of restitution between the spheres is e . Find, in terms of e , the speeds of A and B after A collides with B . [5]

Given that the spheres move in opposite directions after the collision, show that $e > \frac{2}{3}$. [1]

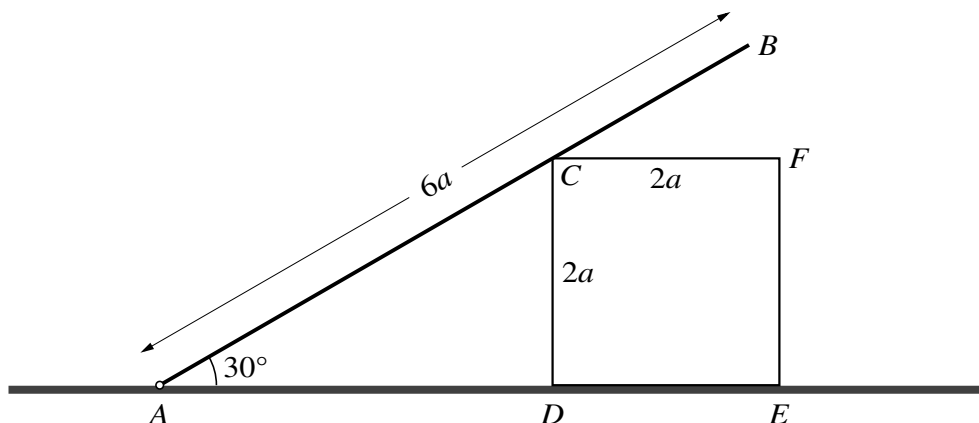
A uniform sphere P of mass m is at rest on a smooth horizontal table. The sphere is projected along the table with speed u and strikes a smooth vertical barrier A at an acute angle α . It then strikes another smooth vertical barrier B which is at right angles to A (see diagram). The coefficient of restitution between P and each of the barriers is e . Show that the final direction of motion of P makes an angle $\frac{1}{2}\pi - \alpha$ with the barrier B and find the total loss in kinetic energy as a result of the two impacts. [7]

- 3 A particle moves on a straight line AOB in simple harmonic motion, where $AB = 2a$ m. The centre of the motion is O and the particle is instantaneously at rest at A and B . The point M is the mid-point of OB . The particle passes through M moving towards O and next achieves its maximum speed one second later. Find the period of the motion. [4]

Find the distance of the particle from O when its speed is equal to one half of its maximum speed. [3]

At an instant 2.5 seconds after the particle passes through M moving towards O , the distance of the particle from O is $\sqrt{2}$ m. Find, in metres, the amplitude of the motion. [2]

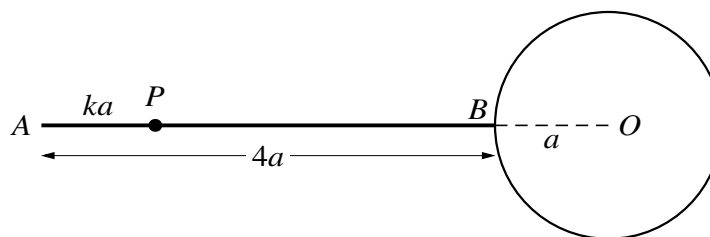


The diagram shows a central cross-section $CDEF$ of a uniform solid cube of weight W and with edges of length $2a$. The cube rests on a rough horizontal plane. A thin uniform rod AB , of weight W and length $6a$, is hinged to the plane at A . The rod rests in smooth contact with the cube at C , with angle CAD equal to 30° . The rod is in the same vertical plane as $CDEF$. The coefficient of friction between the plane and the cube is μ . Given that the system is in equilibrium, show that $\mu \geq \frac{3}{25}\sqrt{3}$. [6]

Find the magnitude of the force acting on the rod at A .

The end B of a uniform rod AB , of mass $3M$ and length $4a$, is rigidly attached to a point on the circumference of a uniform disc. The disc has centre O , mass $2M$ and radius a , and ABO is a straight line. The disc and the rod are in the same vertical plane. A particle P , of mass M , is attached to the rod at a distance ka from A , where k is a positive constant (see diagram). Show that the moment of inertia of this system, about a fixed horizontal axis l through A perpendicular to the plane of the disc, is $(67 + k^2)Ma^2$. [5]

The system is free to rotate about l and performs small oscillations of period $4\pi\sqrt{\left(\frac{a}{g}\right)}$. Find the possible values of k . [6]

- 6 The reliability of the broadband connection received from two suppliers, A and B , is classified as good, fair or poor by a random sample of householders. The information collected is summarised in the following table.

		Reliability		
		Good	Fair	Poor
Supplier	A	65	63	33
	B	51	44	44

Test, at the 5% significance level, whether reliability is independent of supplier. [8]

- 7 For a random sample of 10 observations of pairs of values (x, y) , the equation of the regression line of y on x is $y = 3.25x - 4.27$. The sum of the ten x values is 15.6 and the product moment correlation coefficient for the sample is 0.56. Find the equation of the regression line of x on y . [7]

Test, at the 5% significance level, whether there is evidence of non-zero correlation between the variables. [4]

- 8 A large number of long jumpers are competing in a national long jump competition. The distances, in metres, jumped by a random sample of 7 competitors are as follows.

6.25 7.01 5.74 6.89 7.24 5.64 6.52

Assuming that distances are normally distributed, test, at the 5% significance level, whether the mean distance jumped by long jumpers in this competition is greater than 6.2 metres. [7]

The distances jumped by another random sample of 8 long jumpers in this competition are recorded. Using the data from this sample of 8 long jumpers, a 95% confidence interval for the population mean, μ metres, is calculated as $5.89 < \mu < 6.75$. Find the unbiased estimates for the population mean and population variance used in this calculation. [5]

- 9 The continuous random variable X has probability density function given by

$$f(x) = \begin{cases} 0 & x < 2, \\ ae^{-(x-2)} & x \geq 2, \end{cases}$$

where a is a constant. Show that $a = 1$. [1]

Find the distribution function of X and hence find the median value of X . [5]

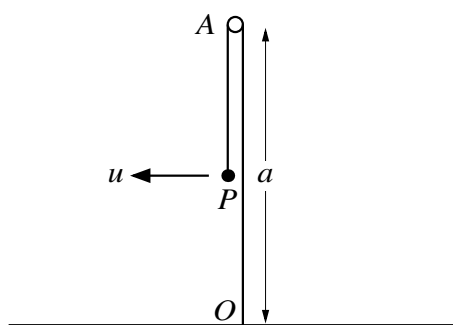
The random variable Y is defined by $Y = e^X$. Find

(i) the probability density function of Y , [4]

(ii) $P(Y > 10)$. [2]

10 Answer only **one** of the following two alternatives.

EITHER



One end of a light inextensible string of length $\frac{3}{2}a$ is attached to a fixed point O on a horizontal surface. The other end of the string is attached to a particle P of mass m . The string passes over a small fixed smooth peg A which is at a distance a vertically above O . The system is in equilibrium with P hanging vertically below A and the string taut. The particle is projected horizontally with speed u (see diagram). When P is at the same horizontal level as A , the tension in the string is T . Show that

$$T = \frac{2m}{a}(u^2 - ag). \quad [3]$$

The ratio of the tensions in the string immediately before, and immediately after, the string loses contact with the peg is 5 : 1.

(i) Show that $u^2 = 5ag$. [6]

(ii) Find, in terms of m and g , the tension in the string when P is next at the same horizontal level as A . [5]

OR

The times taken, in hours, by cyclists from two different clubs, A and B , to complete a 50 km time trial are being compared. The times taken by a cyclist from club A and by a cyclist from club B are denoted by t_A and t_B respectively. A random sample of 50 cyclists from A and a random sample of 60 cyclists from B give the following summarised data.

$$\Sigma t_A = 102.0 \quad \Sigma t_A^2 = 215.18 \quad \Sigma t_B = 129.0 \quad \Sigma t_B^2 = 282.3$$

Using a 5% significance level, test whether, on average, cyclists from club A take less time to complete the time trial than cyclists from club B . [10]

A test at the $\alpha\%$ significance level shows that there is evidence that the population mean time for cyclists from club B exceeds the population mean time for cyclists from club A by more than 0.05 hours. Find the set of possible values of α . [4]
